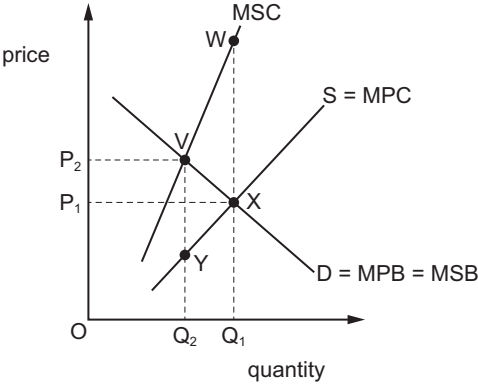


6 The diagram shows market failure caused by negative production externalities.

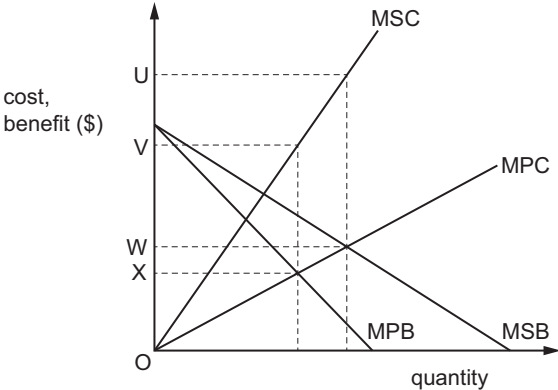

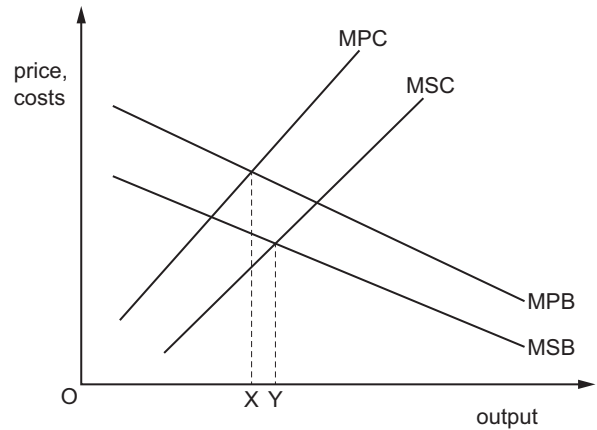
3 The diagram shows the marginal costs and marginal benefits of producing a good in a free market.
