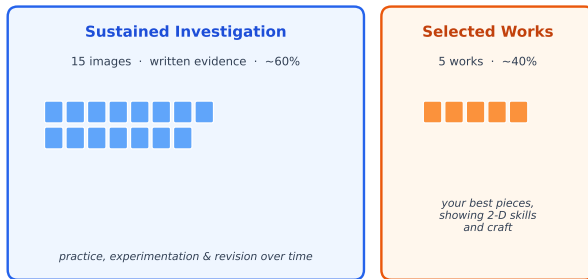
The portfolio

The AP exam is a portfolio, not a written test

Big Idea 3 is about **presenting**. The **portfolio** 作品集 has **two sections**, both submitted **digitally**.

There is **no timed exam** – the portfolio is built across the **whole course**.

The portfolio is a 15-image Sustained Investigation plus 5 Selected Works, submitted as digital images

The two sections at a glance

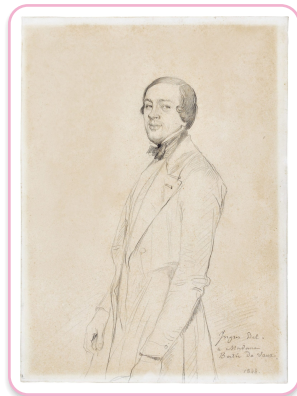
Sustained Investigation 持续探究

15 images showing inquiry, practice, experimentation and revision
+ written evidence
weighted more than Selected Works

Selected Works 精选作品

5 works that best show your 2-D skills
+ materials, processes, ideas and size
they need not belong to the investigation

Works may be physical or digital
– but all are submitted as digital images.



Selected works show sustained craft

Sustained Investigation – images and written evidence

Judged on the **inquiry** and the **practice**,
experimentation and revision it shows.

- 15 images – works **and** process documentation, over time
- written evidence: name the **guiding questions** 引导性问题
- describe **how** the work shows the three actions

Images should **tell the story of the inquiry**, not just show finished pieces – detail and **in-progress** shots are allowed.

Selected Works: Demonstrating Skills

The Selected Works section shows your best evidence of **2-D skills** 二维技能 and synthesis of materials, processes, and ideas.

- Submit **5 works** (physical or digital) as high-quality images.
- For each, give the **materials, processes, and ideas** used, plus the size.
- These works are judged mainly on the skilful use of the elements and principles; they need not belong to the sustained investigation.

Writing & presentation

Writing about your work

Writing communicates inquiry, processes and ideas to viewers who **cannot ask you questions**.

- stay within character limits – concise and **specific**
- state the guiding question clearly
- use **evidence**, not vague claims

Idea → **process** → **revision** beats describing finished pictures.



Written evidence starts from inquiry notes and tests

Presentation and image quality

Image quality is **part of the grade** – poor images can **hide real skill**.

- even lighting, sharp focus, true colour
- crop to the work; avoid glare and keystoneing
- keep resolution high



Selected works need clear craft and presentation quality

Scoring & integrity

Understanding the scoring guidelines

Both sections are scored against **published scoring guidelines** 评分标准:

Sustained Investigation –
inquiry + evidence of practice, experimentation, revision

Selected Works – 2-D skills + synthesis of materials, processes, ideas

Readers use **visual evidence in the work** *plus* your writing to apply the criteria.

Design your work **with the criteria in mind** – but **not to a formula**.

Academic integrity and citing sources

Portfolios must be your **own** work – using others' work without permission or citation is a **serious violation**.

- work from **published sources** 参考来源 you did not create must move **far beyond duplication** and **cite** 注明出处 the source
- never present another artist's work – or an **AI-generated image** – as your own

Citing influences shows **integrity** 诚信, **not weakness**.

When in doubt, work from **your own** photos, observation and imagination.

Worked example – writing the investigation statement

For the Sustained Investigation you write a short statement about your inquiry and how the work developed.

- *“My inquiry asked how repetition can show the passing of time. I began with pencil grids, then moved to printmaking so I could repeat one image with small changes, revising the spacing in later prints to slow the visual rhythm.”*
- Idea, materials, and **change** – in one or two sentences.

The statement is evidence of decision-making. A description of the finished work, with no revision named, evidences nothing.
