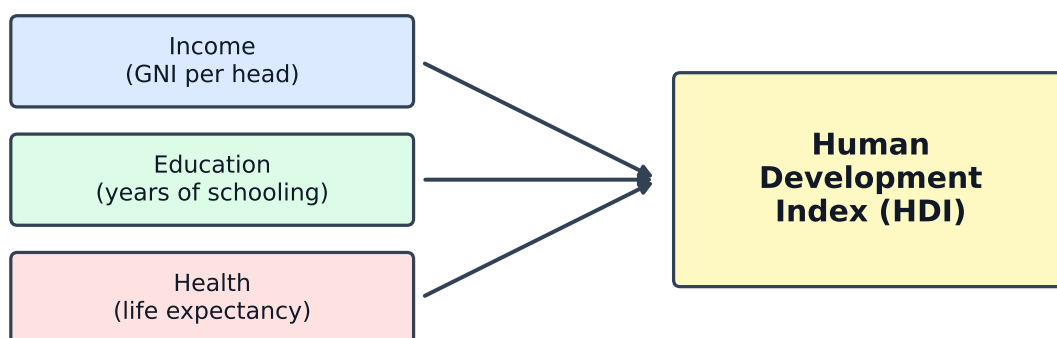

■ Measuring living standards



Exam: $HDI = income + education + health$ — broader than GDP alone for living standards

Living standards = income, health, education and quality of life

- **Real GDP per head** 人均实际 GDP: total output $\div$ population, after removing inflation $\rightarrow$ roughly average income.
- **HDI** 人类发展指数 (0 to 1): combines income, education (years of schooling), health (**life expectancy** 预期寿命).
- **Limits of GDP per head**: it is an average (hides **income distribution** 收入分配), omits unpaid work, pollution and free time.

Absolute poverty

cannot afford basic needs:
food, clean water,
shelter and clothing

Relative poverty

poor compared with others
in the same country —
can afford basics,
but much less than most

Exam: absolute = cannot meet basic needs; relative = far below the country's typical living standard

An average can hide poverty — high GDP per head still leaves people in absolute or relative poverty

2.1 the total real output (real GDP) of a country divided by its population — roughly the average income per person (2 for a clear definition; 1 for a partial idea).

2.2 income (per head); education (years of schooling); health (life expectancy) (1 + 1 + 1).

2.3 any one of: it is an average that hides income distribution; it omits unpaid work, pollution and free time (1).

3.1 C. The inflation rate is not part of the HDI.

3.2 [4] K 1 + An up to 3 — GDP per head measures only average income, which can hide poor health or low schooling and uneven distribution → the HDI adds life expectancy and education → so it captures the wider quality of life, giving a fuller picture of living standards.

3.3 [6] K/App/An — GDP per head is only an average of income, so two countries with the same figure can differ widely: in one, income may be shared fairly with good health and education; in the other, a few rich people may pull the average up while most are poor with poor schooling and short life expectancy → factors like income distribution, health, education, pollution and free time all affect living standards beyond average income.

■ Two types of poverty

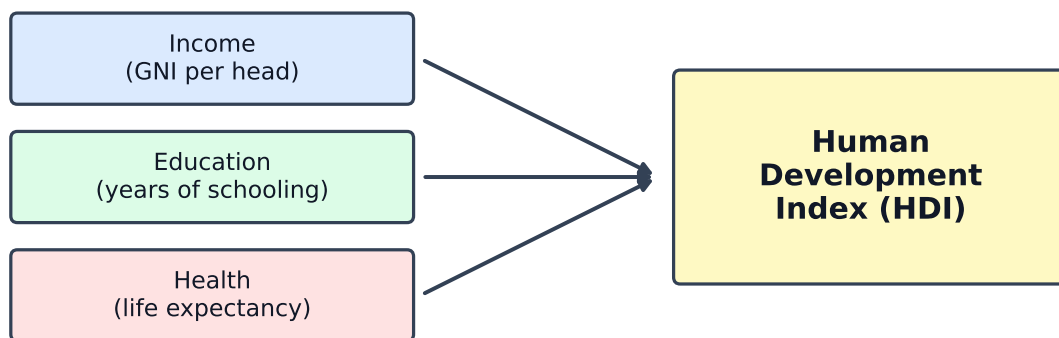
Absolute poverty cannot afford basic needs: food, clean water, shelter and clothing	Relative poverty poor compared with others in the same country — can afford basics, but much less than most
--	--

Exam: absolute = cannot meet basic needs; relative = far below the country's typical living standard

Poverty: when people cannot afford a basic standard of living

- **Absolute poverty** 绝对贫困: cannot afford even basics (food, clean water, shelter).
- **Relative poverty** 相对贫困: poor *compared with others* in the same country.
- **Causes:** low income/wages or unemployment, poor education and health, old age, large families.
- **Policies:** **economic growth** 经济增长, **redistribute** 再分配 income, a **mini-**

mum wage 最低工资, **benefits** 福利, better state education/healthcare.



Exam: $\text{HDI} = \text{income} + \text{education} + \text{health}$ — broader than GDP alone for living standards

Poverty and development move together — the HDI captures the income, health and education a poor country lacks

2.2 absolute poverty means lacking basic needs; relative poverty means being poor compared with most others in the same country (2 for a clear difference; 1 for a partial idea).

2.3 any two of: low income/wages; unemployment; poor education or health; old age; large families (1 + 1).

3.1 B. Being poor compared with others in the same country is relative poverty.

3.2 [4] For **each** of two policies: K 1 + An 1 — *benefits*: cash payments raise the income of the poorest → less absolute poverty; *minimum wage*: a legal lowest wage raises the pay of low-paid workers → fewer of the working poor.

3.3 [8] K/App/An up to 5 + Ev up to 3. **For growth**: a growing economy creates jobs and incomes, and gives the government more tax to fund help for the poor. **Against**: if the gains go mostly to the rich, growth can leave the poor behind (relative poverty may even rise), and growth alone does not guarantee schools, healthcare or benefits reach them. **Judgement (Ev)**: growth helps reduce poverty when its gains are shared, but it works best combined with redistribution and better services — so it is not enough on its own.

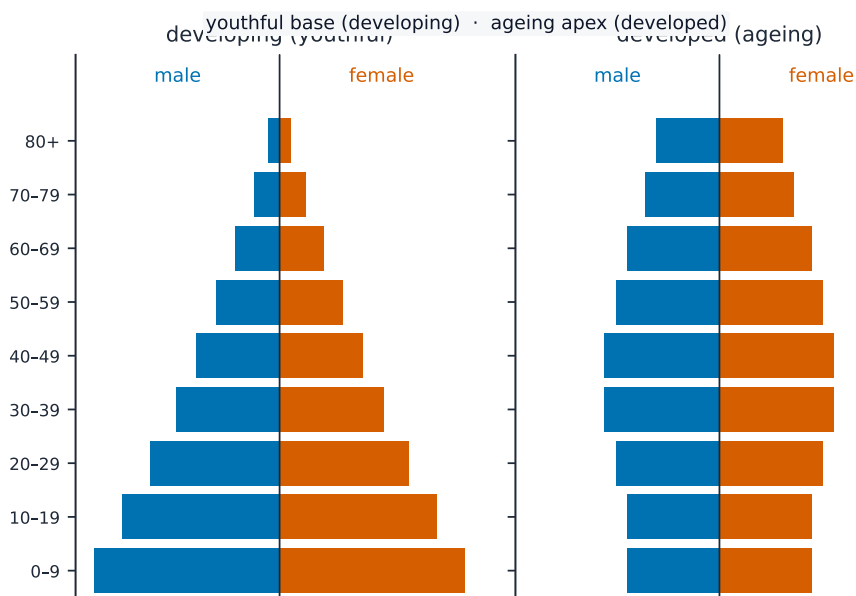

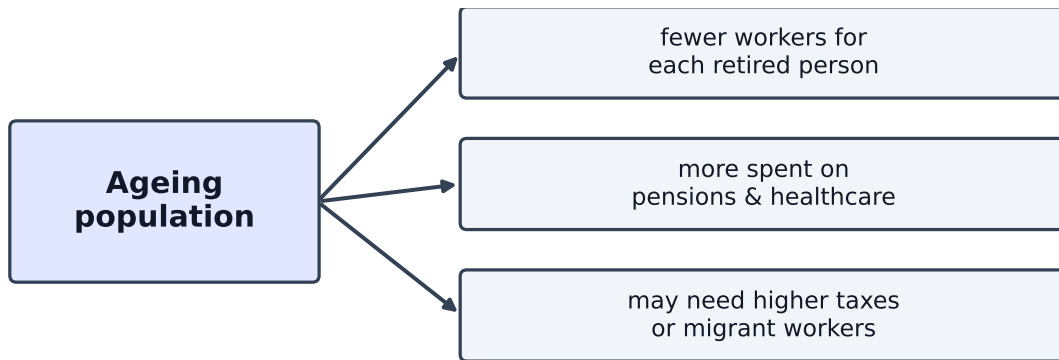
■ Population change and structure



Population grows when $\text{births} + \text{immigration} > \text{deaths} + \text{emigration}$

- **Birth rate** 出生率 / **death rate** 死亡率: births/deaths per 1000 people per year.

- **Migration** 移民: **immigration** 迁入 (in) and **emigration** 迁出 (out); **net migration** 净移民 = in – out.
- **Ageing population** 人口老龄化: people live longer and have fewer children → more retired people per worker, higher pension and healthcare costs.



Exam: ageing raises dependency ratio — pressure on pensions, healthcare, and tax base

An ageing population: the worker-to-retiree ratio falls, raising pension and healthcare costs

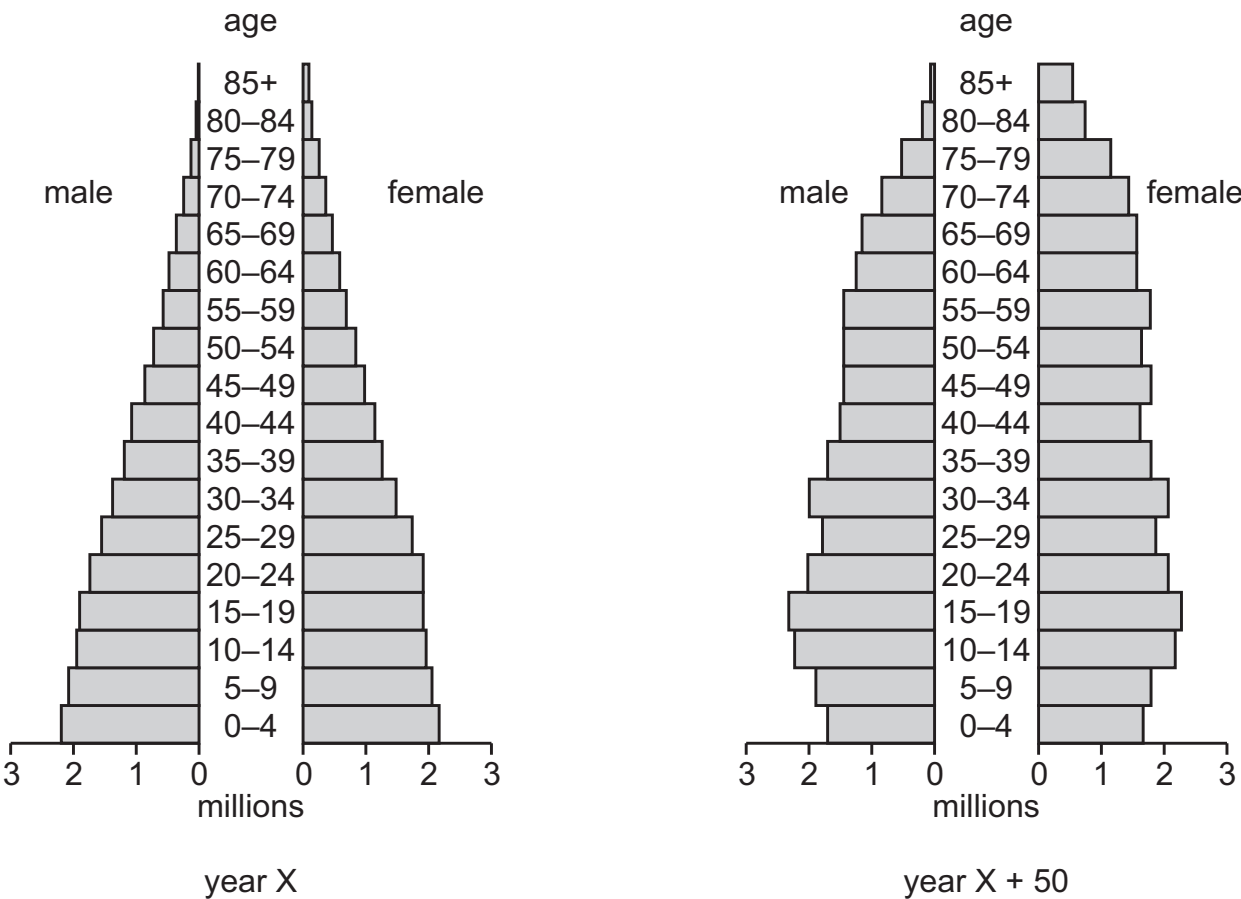

3.2 [4] For **each** of two reasons: K 1 + An 1 — *longer life expectancy*: better healthcare means people live longer → more old people; *a falling birth rate*: families have fewer children → the share of young people falls, so the population ages.

3.3 [6] K/App/An — an ageing population has more retired people and fewer workers → each worker must support more people → the government spends more on pensions and healthcare → it may need higher taxes or more immigrant workers to fill the gap → so an ageing population raises costs and can slow growth unless productivity rises.

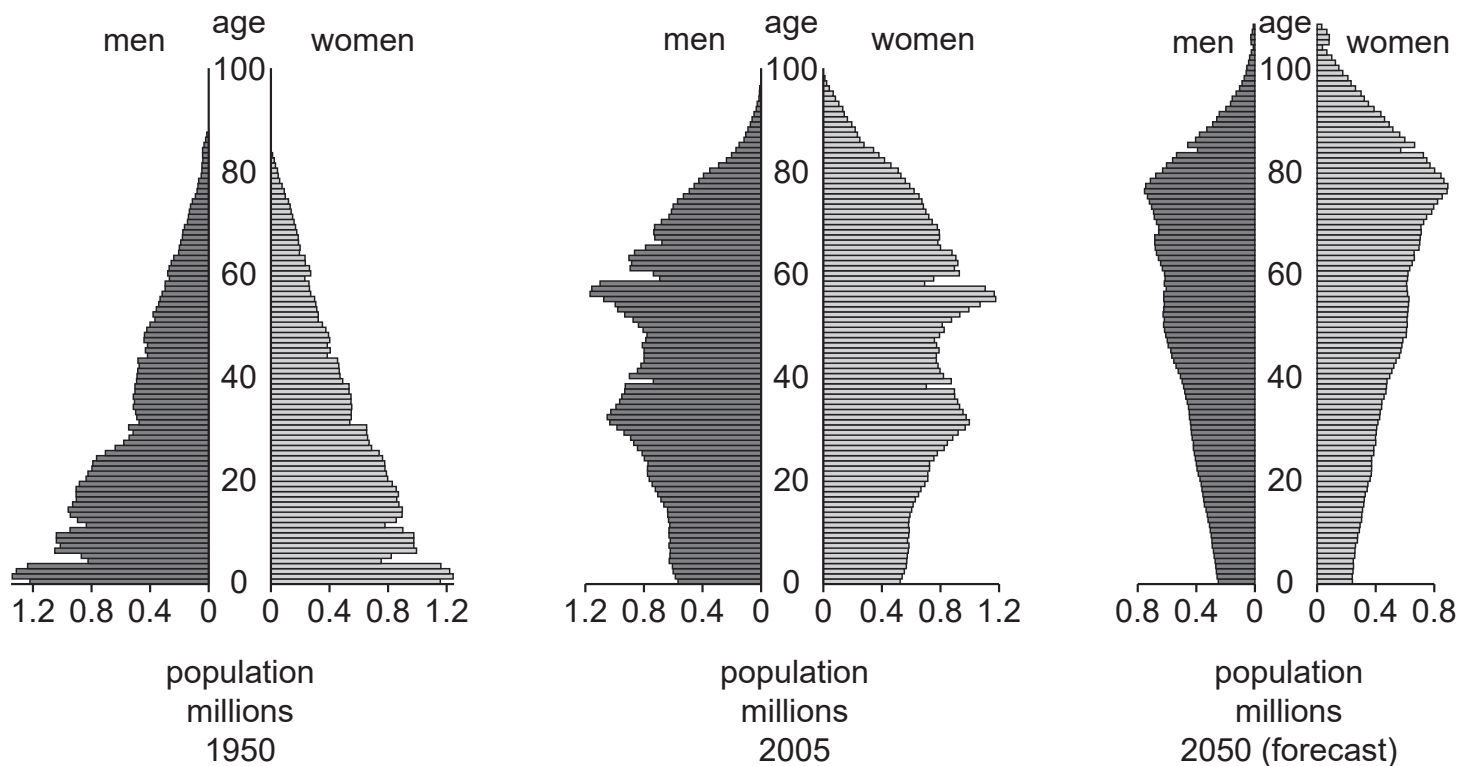

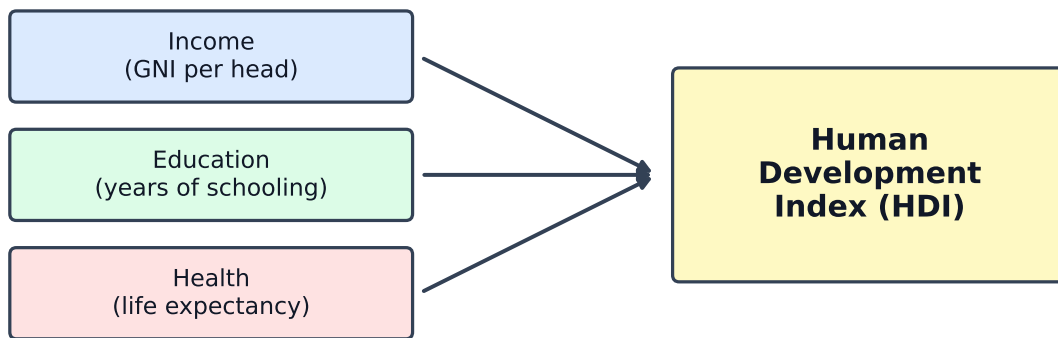

■ Developed and developing countries



Development is about well-being, not just output

- **Economic development** 经济发展: a rise in people's well-being (health, education, income), not just more output.
- **Why countries differ:** income, **productivity** 生产率 (developing often do **subsistence farming** 自给农业), population, education and health, **debt** 债务, trade.
- **Linked:** developing countries sell raw materials and buy machines; trade, aid and investment can help — but cause dependency.



Exam: HDI = income + education + health — broader than GDP alone for living standards

The HDI puts a number on the development gap — income, health and education compared across countries

Answer shapes: K + App + An + Ev (a justified judgement, for discuss questions).

2.1 growth is a rise in real output (GDP); development is a rise in people's well-being — health, education and income — not just output (2 for a clear difference; 1 for a partial idea).

2.3 growing food only for one's own family, with little or none to sell (2 for a clear definition; 1 for a partial idea).

3.1 C. Developing countries usually have a higher birth rate.

3.2 [4] For **each** of two reasons: K 1 + An 1 — *low productivity*: less capital and skill, and much subsistence farming, so each worker produces little → low incomes; *debt*: large debt repayments leave less for schools and hospitals → development and incomes stay low.

3.3 [8] K/App/An up to 5 + Ev up to 3. **Helps:** trade brings income, lets a country specialise, and gives access to machines and technology it cannot make itself. **Harm:** developing countries may rely on a few low-value primary exports with unstable prices, while importing high-value goods, and can become dependent. **Judgement (Ev):** trade can aid development, but mainly if the country can move into higher-value goods and is not left dependent on volatile primary exports — so it depends on what it trades and on fair terms.
