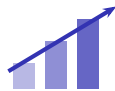

Living standards and HDI

Real GDP per head 人均实际 GDP measures average income.

The **HDI** 人类发展指数 adds education & health (**life expectancy** 预期寿命) – a fuller picture than GDP alone.



Living standards rise with development

Indicators of living standards

an indicator 指标	a number used to measure something we cannot observe directly
GDP per head 人均国内生产总值	total output divided by population – simple, and blind to distribution
the HDI 人类发展指数	combines income, life expectancy and education into one index
why HDI is better	two countries with equal income can differ by decades of life expectancy
what both miss	inequality, unpaid work, the environment, and how safe or free people feel

No single number measures a standard of living. Every comparison question wants at least two indicators and a note on what they leave out.

└ Living standards

Measuring how well a country lives

GDP	Gross domestic product 国内生产总值: total output in a year. Per head, it is the usual first comparison – and it hides how the income is shared.
HDI	The Human Development Index 人类发展指数 adds health and education to income, giving a score from 0 to 1.
Other signs	Doctors per person, clean water, school enrolment, internet use – each fills a gap the income figure leaves.
Economic growth	Economic growth 经济增长 raises the average, and only redistribute 再分配-style policy decides who receives it.

Higher **productivity** 生产率 is what makes growth durable: output per worker, not hours worked.

Limits of the comparison

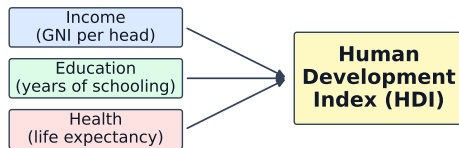
Comparing living standards is not simple:

- GDP per head is an *average*. It hides the **income distribution** 收入分配 – a country can have a high average but a few rich people and many poor people.
- it leaves out unpaid work, and work in the hidden economy.
- it does not measure pollution, free time, or safety.
- prices and money differ between countries, so the same income buys different amounts.

Living standards and HDI – measures, in detail



Exam: HDI = income + education + health — broader than GDP alone for living standards

It hides the **income distribution** 收入分配 – a country can have a high average but a few rich people and many poor people.

Poverty

- **absolute poverty** 绝对贫困 – cannot afford the basics
- **relative poverty** 相对贫困 – poor *compared* with others

Low income & poor health trap people in a **poverty cycle** 贫困循环.



Poverty limits choices and opportunity

Poverty – types

- **absolute poverty** 绝对贫困 – people cannot afford even the basics: enough food, clean water, shelter, and clothing.
- **relative poverty** 相对贫困 – people are poor *compared with others* in the same country. They can afford the basics but much less than most people around them.

Poverty – types, in detail

Absolute poverty

cannot afford basic needs: food, clean water, shelter and clothing

Relative poverty

poor compared with others in the same country — can afford basics, but much less than most

Exam: absolute = cannot meet basic needs; relative = far below the country's typical living standard

They can afford the basics but much less than most people around them.

The causes of poverty, and the policies against it

low income	low wages 工资, or no job at all
life stage	old age, or having many children to support
lack of education	which limits what work is available
a minimum wage 最低工资	a legal lowest wage, so low-paid workers earn more – with a risk to jobs if set too high
progressive tax and benefits	transferring income from higher to lower earners
state education and healthcare	so the poor can improve their own position rather than only receive transfers

The last row is the one that changes the cause rather than the symptom, which is why development questions favour it.

Living standards

Why poverty persists, and who is affected

Subsistence farming	Subsistence farming 自给农业 feeds the family but earns almost no cash income – so there is nothing to save or invest.
Debt	National debt 债务 repayments take money that could have gone to schools and clinics.
Population structure	A young population structure 人口结构 means many dependants per worker; an ageing one shifts the burden to pensions and healthcare.
Unemployment and skills	No work, or no qualifications for the work available – the reason poverty passes from one generation to the next.

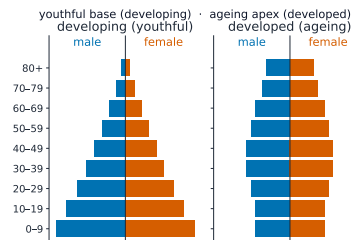
Absolute poverty is not having the necessities; relative poverty is falling far behind the country's own standard. Policies for the two differ.

Population

Population



Population grows when **births** 出生 exceed **deaths** 死亡 (plus migration).

A **population pyramid** 人口金字塔: a developing country has a wide young base; a developed one is more even.

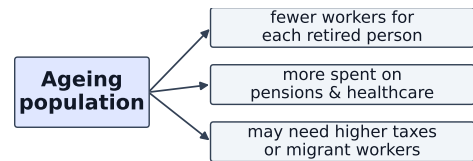
Ageing population

An **ageing population** 人口老龄化 has more older people & fewer workers. This raises spending on **pensions** 养老金 & health, paid by fewer workers.

Ageing population, in detail



Exam: ageing raises dependency ratio — pressure on pensions, healthcare, and tax base

An **ageing population** 人口老龄化 has more older people & fewer workers.

The development gap

Developed 发达 countries have high incomes & good services; **developing** 发展中 ones less so. Development comes from investment in capital, education & health.

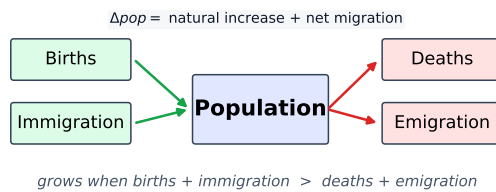
developed	developing
high income	low income
good health	poorer health
more schooling	less schooling

How developed and developing countries are linked

Developing countries sell raw materials and cheap goods to developed countries, and buy machines and skills from them.

Trade, aid, and investment from richer countries can help poorer countries develop – but developing countries can also become too dependent on them.

Population, continued



A country's population grows when births plus immigration are greater than deaths plus emigration

The population rates, and what they do

the birth rate 出生率	births each year per 1000 people
the death rate 死亡率	deaths each year per 1000 people
natural change	birth rate minus death rate – before migration is counted
net migration	immigration minus emigration; added to natural change gives population growth
an ageing population 人口老龄化	a rising share of over-65s: higher pension and healthcare costs, a shrinking workforce, and a higher dependency ratio
a young population	the opposite pressures – schools and jobs rather than pensions

"Per 1000" is what makes the rates comparable between countries of very different sizes. Quoting raw numbers instead loses the mark.

Exam tips

- **Real GDP per head** = $GDP \div \text{population}$, but it is an *average* that hides how income is shared. **HDI** adds health and education for a fuller picture.
- A population grows when births + immigration is greater than deaths + emigration. **Net migration** = immigration – emigration.
- An **ageing population** means fewer workers for each retired person, so more government spending on pensions and healthcare.
- Distinguish **absolute poverty** (cannot afford basic needs like food and shelter) from **relative poverty** (poor compared with others in the same country).

3 Recap

Worked example – GDP per head

Real GDP is £600bn and the population is 50 million. Find real GDP per head.

- GDP per head = $\frac{\text{real GDP}}{\text{population}}$
- = $\frac{£600,000,000,000}{50,000,000} = £12,000$
- It is an *average* – it hides how unequally the income is shared.
- It also ignores *quality of life*: health, education, pollution, leisure.

GDP per head compares *living standards* across countries of different size. For a fuller picture use the *HDI*: income *plus* health and education.

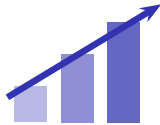
